

1. **For Attachment G-Fee Proposal:**

- In reading the scope of work for a few of the services included, we have different names/providers who perform these duties, such as:
  - C-Occupational Therapist
    - We implement a COTA/OT model to deliver OT services
  - E-School Psych: 3. Specially Designed Vocational Education and Career Development
    - We have transition consultant who supports with this role
  - F-School Psychologist Leads: 1. Provide assistance with the SELPA Application Process
    - We have our Program Administrators fulfill this role
  - G. Speech and Language Pathologist
    - We implement a SLPA/SLP model to deliver LAS services
  - H. Compliance Coordinator + I. Compliance Coordinator Assistant
    - We have our Case Managers/Program Administrators fulfill these roles
  - J. Paraprofessional (or Office Staff):
    - 2/4 Our paraprofessionals would implement but the design, development and special programming would be completed by your SpEd Credentialed provider or an additional service can be rendered by our BCBA's.
    - 5. Our BCBA's can provide the consultation support and our paraprofessionals if NCI certification is required, can implement strategies as needed.
